DOCTORS IN SECONDARY SCHOOLS

Sale College was successful in being selected to participate in the Victorian Government's Doctors in Secondary Schools program. As part of this program, an adolescent-trained GP (general practitioner) from Inglis Street Medical Centre will be operating on school grounds each Wednesday morning from 9am -10:30am at the Guthridge Campus and 12:30pm-3pm at the Macalister Campus to provide free access to primary health care for secondary students at our school. The GP will provide students with the same services as the kind normally provided by GPs in the community, including seeing students about their physical and mental health, and sexual and reproductive health issues. GPs may also make referrals to other health services as required. The GP will bulk bill consultations through Medicare, so there will be no out-of-pocket expenses for this service for your family. This program is not designed to replace any existing medical arrangements your family may have in place. The GP in the school can provide a convenient alternative to primary care within schools hours, and encourage health care access to those students without an existing relationship with a GP. The program is intended to provide better access to primary care for secondary school students. If you would like to make an appointment please call or text **0437 513 410** or contact either campus front office.

SCHOOL BUS TRAVEL



Families who live in the towns surrounding Sale may be eligible to travel on the Sale Country Bus Network. To be eligible for travel on a country network school bus at no cost, government students must attend their nearest government school. Students must reside at least 4.8 km or more from the school. The distance is measured by the shortest practicable route from the student's front gate to the school's main entrance. For people who would like to register for travel on the Country Bus Network, please fill in an Application to Travel form and return to the front offices. We will assess your application and make you an offer which you will need to accept or decline and we will send you a bus pass.

Country Bus Travellers will only be allowed access with a Bus Pass issued by the school.

Students not attending their closest school may be accommodated on a bus service as long as they pay a fare and seating capacity exists. Please fill in an Application to Travel Fare Paying form and return to the front office.

SCHOOL UNIFORM



DESCRIPTION OF UNIFORM

- College Zip Up Jacket.
- Plain black pants
- Black summer shorts (with or without college logo) of approved style and material
- School polo shirt with Logo
- A plain black long sleeve may be worn beneath the shirt Dress of approved style and material.
- Dress of approved style and material.
- Winter skirt of approved style and material.
- Black tights
- Plain white or black socks
- Black enclosed shoes or runners (leather or vinyl)
- Bucket Hat with Logo

Points to note:

- · Scuffs, thongs, sandals and raised heels are not acceptable for health and safety reasons. School approved footwear should always be worn. For practical subjects safety dictates that students must wear an enclosed shoe and may be excluded if not compliant.
- ·The VCE jacket is an acceptable alternative top for Year 12 students. There is a restriction on the colours allowed and the final design is approved by the Principal.
- · Music uniform students who are members of the Sale College Bands are permitted to wear the band uniform during performances.
- **Specifically excluded (not approved):** Cargo style pants or shorts, Corduroy pants/shorts of all types, Ballet flats, black skirts and hoodies.

All school uniform should meet the 'Sale College Dress Code' - this will be addressed on an individual basis






MACALISTER CAMPUS MAP

MOBILE PHONE POLICY



PURPOSE

To explain to our school community the Department's and Sale College policy requirements and expectations relating to students using mobile phones during school hours

SCOPE

This policy applies to:

- 1. All students at Sale College and,
- 2. Students' personal mobile phones brought onto school premises during school hours, including recess and lunchtime

DEFINITIONS

A mobile phone is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network

POLICY

Sale College understands that students may bring a personal mobile phone to school, particularly if they are travelling independently to and from school.

At Sale College:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours, which is in their lockers, year level offices or front offices.
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

Personal mobile phone use

In accordance with the Department's <u>Mobile Phones Policy</u> issued by the Minister for Education, personal mobile phones must not be used at Sale College during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

Secure storage

Mobile phones owned by students at Sale College are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone to school unless there is a compelling reason to do so. Please note that Sale College does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items.

Where students bring a mobile phone to school, Sale College will provide secure storage. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Sale College students are required to store their phones in their own lockers. Students are not to store their phones in a friends' locker nor should any they allow other students to store mobile phones in their locker. Furthermore students should ensure that no other person can access their locker.

Enforcement

Students who use their personal mobile phones inappropriately at Sale College may be issues with consequences consistent with our school's existing student engagement policies.

At Sale College inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted, and particularly use of a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms during exams and assessments



Exceptions

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
- A Health and wellbeing-related exceptions; and
- Exceptions related to managing risk when students are offsite.
- can be granted by the principal, or by the teacher for that class, in accordance with the Department's Mobile Phones Policy.

The three categories of exceptions allowed under the Department's Mobile Phones Policy are:

- 1. Learning-related exceptions
- 2. Health and wellbeing-related exceptions

3. Exceptions related to managing risk when students are offsite

Where an exception is granted, the student can only use the mobile phone for the purpose for which it was granted.

Camps, excursions and extracurricular activities

Sale College will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones. In general, mobile phones can be brought onto camps/excursions but certain restrictions may be put in place during the camp.

Exclusions

This policy does not apply to

- Out-of-School-Hours Care (OSHC)
- Out-of-school-hours events
- Travelling to and from school
- iPads and all other personal devices
- Students undertaking workplace learning activities, e.g. work experience
